SWORN COMPLAINT BEFORE THE TEXAS ETHICS COMMISSION

An individual must be a resident of the state of Texas to be eligible to file a sworn complaint with the Texas Ethics Commission. The complainant is required to attach to the complaint a copy of one of the following documents:

- complainant's driver's license or personal identification certificate issued under Chapter 521 of the Transportation Code, or commercial driver's license issued under Chapter 522 of the Transportation Code; or
- a utility bill, bank statement, government check, paycheck or other government document that shows the name and address of the complainant and is dated not more than 30 days before the date on which the complaint is filed.

Effective September 1, 2009, an individual may also be eligible to file a sworn complaint with the Texas Ethics Commission if the individual owns real property in the state of Texas. Under this provision, the complainant will be required to attach to the complaint a copy of a property tax bill, notice of appraised value, or other government document that shows the name of the complainant, shows the address of the real property in Texas, and identifies the complainant as the owner of the real property.

The Texas Ethics Commission has jurisdiction to enforce only the following laws: (1) Title 15 of the Election Code; (2) Chapters 302, 303, 305, 572, 2004 of the Gov't Code; (3) § 334.025 and § 335.055 of the Local Gov't Code; (4) Subchapter C, Chapter 159 of the Local Gov't Code, in connection with a county judicial officer who elects to file a financial statement with the commission; (5) § 2152.064 and § 2155.003 of the Gov't Code; (6) § 306.005 of the Gov't Code.

Kristi Lara has violated section 255.006 of the Texas Elections Code by knowingly representing in campaign communications that she holds a public office that she does not hold.

Section 255.006(b) states: "A person commits an offense if the person knowingly represents in a campaign communication that a candidate holds a public office that the candidate does not hold at the time the representation is made." Subsection (c) then explains that a person "represents that a candidate holds a public office that the candidate does not hold "if (1) the candidate does not hold that office (i.e., is not an incumbent) and (2) the communication does not include the word "for."

Her signs and bumper stickers do not include the word "for," as required by section 255.006(c)(2), and therefore by definition represent that she holds a public office she does not hold under section 255.006(b). Lara has also posted images of the yard signs and the bumper stickers mentions above, among other similar graphics, on her campaign facebook page found at www.facebook.com/kristi.lara.92.

Additionally, based on information and belief, Kristi Lara mailed post card flyers to an unknown number of Dallas residents that also failed to include the word "for" causing those campaign materials to also violate section 255.00 (b) The Elections Code violations described herein were committed on or before October 24, 2013.




