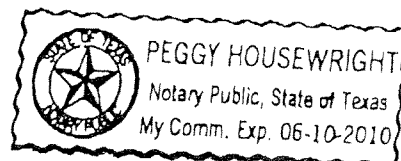

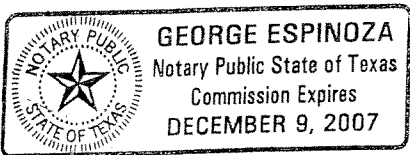

when we was writing down information, Mr. Watkins stated again you must don't know who I am (smart mouth like) then pull out his badge I am the District Att. for Dallas County.

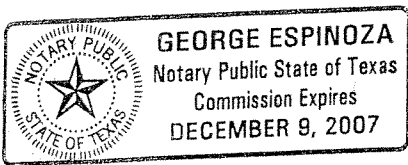
Mr. Watkins stated that he was looking down at something and he did not finish the statement so my first thought was he was not paying attention and did not realize his car was moving.

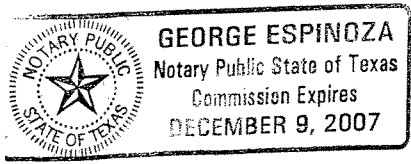

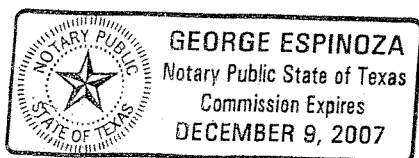
