Dear Mr. Kleinman:

I am writing on behalf of the Dallas Police Association and the Dallas Firefighters Association. As you know, at one time both associations endorsed your candidacy for Dallas City Council District 11, however, both organizations withdrew their political endorsements in writing on August 8, 2016 and have, on numerous occasions, asked you to remove the organizations' names from the list of endorsements published on your campaign website. Despite these requests, you have failed to do so.

No doubt you are aware that the City of Dallas adopts the ethical practices as set forth in the Texas Election Code, specifically the Code of Fair Campaign Practices, which promotes the concept of honesty and transparency with the public in publicizing political endorsements. In that regard, my clients respectfully demand that any reference to the Dallas Police Association and the Dallas Firefighters Association be removed from your website and any other campaign materials or communications, including but not limited to social media, direct mail, press releases, bill boards, websites and fundraising materials.

Your time and immediate attention to this matter is requested.
