AND THE GRAND JURORS AFORESAID do further present in and to said Court that on or about the 25th day of January, 2018, and anterior to the presentment of this Indictment, in the County and State aforesaid WILLIAM DAVIS did then and there, then and there intentionally, knowingly, and recklessly cause bodily injury to Joseph Kalina by introducing air into the arterial system of Joseph Kalina, and the defendant did then and there use or exhibit a deadly weapon, namely a syringe, during commission of the assault;

And it is further presented that the defendant used or exhibited a deadly weapon, to-wit: syringe, that in the manner and means of its use and intended use was capable of causing death and serious bodily injury, during the commission of or immediate flight from said offense;

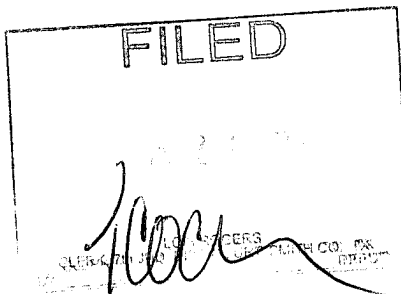

AND THE GRAND JURORS AFORESAID do further present in and to said Court that on or about the 4th day of August, 2017, and anterior to the presentment of this Indictment, in the County and State aforesaid WILLIAM DAVIS did then and there, with intent to cause serious bodily injury to an individual, namely, Christopher Greenaway, commit an act clearly dangerous to human life that caused the death of said Christopher Greenaway, by introducing air into the arterial system of Christopher Greenaway;

And it is further presented that the defendant used or exhibited a deadly weapon, to-wit: a syringe, that in the manner and means of its use and intended use was capable of causing death and serious bodily injury, during the commission of or immediate flight from said offense;
