ETHICS ADVISORY COMMISSION

COMPLAINT FORM INSTRUCTIONS

1. Any resident of the city or any person doing business or attempting to do business with the city (other than a member of the Ethics Advisory Commission) or any city official or employee who believes there has been a violation of the Ethics Code may file a sworn complaint using the attached complaint form. The attached complaint form must be completed, signed and sworn to under penalty of perjury before a Notary Public.
2. The sworn complaint must be filed with the Office of the City Secretary, Room 5DS, City Hall, 1500 Marilla Street, Dallas, Texas, 75201.
3. **FILING A COMPLAINT THAT FALSELY ACCUSES SOMEONE OF A VIOLATION OF THE ETHICS CODE MAY RESULT IN SANCTIONS ISSUED BY THE ETHICS ADVISORY COMMISSION, IN CRIMINAL PROSECUTION OF ANYONE WHO KNOWINGLY MAKES A FALSE ACCUSATION, OR BOTH.**
4. Promptly after receipt of the sworn complaint, the city secretary will acknowledge, in writing, receipt of the complaint to the complainant and will review the complaint for completeness. Upon acceptance of a complete complaint, the city secretary will forward a copy of the complaint to the chair of the Ethics Advisory Commission and to the person charged in the complaint. The person charged in the complaint shall have the opportunity to submit a sworn statement, together with such other information as he or she feels is relevant. If the complaint is not complete, the city secretary will notify the complainant in writing that the complaint is incomplete. The complainant shall have 20 days after the date of the notice to provide the required information, or the complaint will not be processed.
5. Within 30 days after receipt of the complaint by the chair, a preliminary panel of the Ethics Advisory Commission shall make a preliminary finding as to whether or not the complaint states a claim under the Ethics Code and is supported by just cause. ("Just cause" means such cause as is found to exist upon a reasonable inquiry that would induce a reasonably intelligent and prudent person to believe that an act or acts constituting an ethical violation has been committed).
6. If the preliminary finding is that the complaint **DOES NOT** state a claim under the Ethics Code or does not have just cause, based upon the statements and evidence submitted, the complaint will be dismissed by the preliminary panel of the Ethics Advisory Commission.
7. If a complaint is summarily dismissed pursuant to a preliminary finding, written notice identifying the reason(s) for the dismissal will be sent to the complainant and the individual about whom the complaint was made.

COMPLAINT FORM INSTRUCTIONS, continued

8. If the complaint is not summarily dismissed by a preliminary panel of the Ethics Advisory Commission, the Ethics Advisory Commission will notify the complainant and the individual about whom the complaint was made of the date of an evidentiary hearing regarding the complaint. Written notice by certified mail or personal service (or by first class mail, facsimile, or email if such consent is given in writing) will be sent to the complainant and the individual about whom the complaint was made not less than **10 days before** the date of the hearing. The notice must state the specific provision(s) of the Ethics Code alleged in the complaint to have been violated. The person charged in the complaint must have notice of the provision of the Ethics Code at issue and be given an opportunity to respond.
9. A complaint alleging violation of Chapter 12A, Dallas City Code, must be filed with the city secretary within **one year** after the date of the alleged violation. Complaints alleging activity more than one year before the date of the alleged violation will not be accepted by the city secretary.
10. If the complaint is dismissed because the evidence failed to establish a violation of the Ethics Code, the Ethics Advisory Commission shall not entertain any other similar complaint based on substantially the same evidence.
11. All papers and communications relating to a complaint must be treated as confidential unless required to be made public by the Public Information Act or other applicable law.

Attachment 1

DESCRIPTION OF COMPLAINT

I. Councilman Thomas's receipt of certain gifts.

On July 10, 2019, D Magazine published an article in which it reported that Councilman Thomas had been the recipient of certain gifts from VisitDallas, a contractor engaged by the City of Dallas to promote the city and its convention center (a copy of this article is attached as Exhibit 1). Linked in the article was a list of recipients of gifts from VisitDallas, along with the gifts received (a copy of this list is attached as Exhibit 2). Between the dates of June 3, 2016 and December 17, 2018, Councilman Thomas received from VisitDallas gifts comprising tickets to six events, five of which were in 2018 (collectively, the "Gifts"). A second D Magazine article dated July 15, 2019 (a copy of which is attached as Exhibit 3) cited the value of just one of the tickets Councilman Thomas received (to a concert by Bruno Mars on October 14, 2018) as having a value of \$591.

II. Councilman Thomas's Annual Gift Disclosure Reports. Violation of Section 12A-5(b) (failure to report gifts)

The July 15, 2019, D Magazine article also included links to Councilman Thomas's Annual Gift Disclosure Reports for the years 2016, 2017 and 2018 (copies of which are attached hereto as Exhibit 4, Exhibit 5 and Exhibit 6, respectively). These Annual Gift Disclosure Reports do not reflect Councilman Thomas's receipt of the Gifts.

III. Councilman Thomas's Official Acts Regarding VisitDallas

On May 15, 2019, Councilman Thomas participated in a council briefing at which the recent audit of VisitDallas was considered, which participation was an official action. Councilman Thomas neither disclosed any economic interest in VisitDallas, nor recused himself from participating in that portion of the council briefing that concerned VisitDallas, nor filed a statement of conflict of interest with the City Secretary's office regarding any conflict of interest with respect to VisitDallas.

Attachment 2

CODE VIOLATIONS

I. Violation of Section 12A-5(a) (acceptance of gifts that tend to reward or influence official conduct)

It is reasonable to infer that the Gifts tend to reward or influence, or be intended to reward or influence Councilman Thomas's official conduct with regard to VisitDallas, making his acceptance of the Gifts a violation of Section 12-5(a) of the Code of Ethics.

II. Violation of Section 12A-5(b) (failure to report gifts)

The aggregate value of the Gifts is not clear, however the July 15, 2019, D Magazine article cites the value of just one ticket received by Councilman Thomas as \$591—far in excess of the \$250 limit which would require that the Gifts be reported. Councilman Thomas's Annual Gift Disclosure Reports fail to report the Gifts in violation of Section 12A-5(b) of the Code of Ethics.

III. Violation of Section 12A-3(a)(4) (official action despite improper economic interest)

Over the course of 2018 VisitDallas engaged in an ongoing pattern and practice of providing gifts to Councilman Thomas; indeed, it made gifts to him no fewer than five times during that year. Accordingly, it is reasonable to infer that Councilman Thomas expected that such gifts would continue to be forthcoming. The value of the Gifts was not de minimis. Accordingly, by his acceptance of the Gifts and his (inferable) anticipation of future gifts, Councilman Thomas gained an economic interest in VisitDallas. On May 15, 2019, despite this economic interest in VisitDallas, Councilman Thomas participated in a council briefing regarding VisitDallas, in violation of Section 12A-3(a)(4) of the Code of Ethics.

III. Violation of Section 12A-12.1(a)(1) and (b)(8) (failure to recuse)

Councilman Thomas's economic interest in VisitDallas requires that he recuse himself from taking official actions with respect to matters involving VisitDallas. Councilman Thomas did not recuse himself from participating in that portion of the May 15, 2019, Council Briefing that concerned VisitDallas, in violation of Sections 12A-12.1(a) and (b)(8) of the Code of Ethics.

IV. Violation of Section 12-12.1(a)(2) (failure to file statement of conflict of interest)

Councilman Thomas has failed to file a statement of conflict of interest with respect to VisitDallas with the City Secretary's office, a violation of Section 12A-12.1(a)(2) of the Code of Ethics.

V. Violation of Section 12-12.1(b)(8) (failure disclose conflict of interest)

Councilman Thomas has failed to disclose his conflict of interest to the City Council as required, a violation of Section 12A-12.1(b)(8).

VI. Other Potential Violations

It remains unclear whether Councilman Thomas actively solicited the Gifts, thereby committing a separate violation under Section 12A-5(a) of the Code of Ethics. In addition, because Councilman Thomas is a salaried official of the City of Dallas and VisitDallas is an instrumentality of the City of Dallas, the Gifts constitute compensation which is required to be reported under the United States Tax Code. Accordingly, if VisitDallas and Councilman Thomas failed to report the Gifts to the IRS, both Councilman Thomas and VisitDallas may have violated federal law and, as a result, Section 12A-1.2(a)(2) of the Code of Ethics.

VII. Prayer for Order to Produce

In order to fully resolve all potential ethics violations relating to Councilman Thomas's receipt of gifts from VisitDallas, the complainant respectfully begs the Ethics Advisory Commission to order the production of all public records comprising (a) communications between and among Councilman Thomas, his Personal Assistant, his Council Liaison and any employee, officer, board member or agent of VisitDallas regarding the Gifts or the related concerts or events and/or Councilman Thomas's official actions with respect to VisitDallas and (b) any reports on Form 1099 or any similar document by which VisitDallas reported to the United States Internal Revenue Service its provision of the Gifts to Councilman Thomas.

We were due a list of City Council members who have used VisitDallas' suite at the American Airlines Center since 2016. The Office of the Attorney General told the city to give it to us. But the city hadn't. A records official claimed the city never got the ruling from the AG.

Yesterday, the city magically found the ruling and sent the list.

Today, we present the list to you. Is it the most exciting list in the world? Maybe not. Two Council members, current southern Dallas representative Casey Thomas and former West Dallas member Monica Alonzo, accepted

tickets. Here is what they attended e last three years:

Monica Alonzo (June 6, 2017—Enrique Iglesias & Pitbull)

Monica Alonzo (November 12, 2017—Latino Mix Live!)

Casey Thomas (June 3, 2016—R. Kelly)

Casey Thomas (May 27, 2018—Justin Timberlake)

Casey Thomas (July 20, 2018—Sam Smith)

Casey Thomas (August 17, 2018—WWW Big 3)

Casey Thomas (October 14, 2018—Bruno Mars)

Casey Thomas (December 12, 2018—Michelle Obama)

That's all, folks.

I am curious how a Council member gets their hands on these tickets, particularly in light of the aghast look on the faces of several of them in February. That was when this ~~first came up~~, when then-Councilman and mayoral candidate Scott Griggs questioned VisitDallas officials about use of the suite. VisitDallas says tickets go to elected officials to help build relationships with outsiders that VisitDallas hosts.

I've reached out to Thomas for comment and will update this story if I hear back.

Also in the document, we get a glimpse of the names of VisitDallas board members and Kay Bailey Hutchison Convention Center staff who have used the suite. Finally, there's a list of VisitDallas employees who've used it. That part is quite long; VisitDallas had at least two

representatives present during each **D** We see that ousted CEO Phillip Jones saw Stevie Nicks, a ho-hum Mavs-Pistons game, and — two straight years — the Trans-Siberian Orchestra.

Here's ~~something the city sent us~~ about how the suite is used. It says elected officials are invited “to help demonstrate the city’s interest in the business.” City Council members and VisitDallas board members accounted for about 1 percent of the 4,275 tickets that were used from 2016 to 2018.

“The use of these tickets plays an important part in how we build relationships and showcase the destination in order to get positive stories written about Dallas and convince decisionmakers to host their meetings and events here,” the memo reads.

~~Here is the whole list.~~ If you see anything interesting, let us know.

Anyway, if there’s a moral here, it’s that you should always complain.

The Texas Monitor ~~picks up where we left off~~ on how one current and one former Dallas City Council member used VisitDallas' American Airlines Center suite. As you'll remember, the city finally sent us a list of people who've used the suite. ~~As we reported~~, the only active City Council member to use it was southern Dallas representative Casey Thomas. The *Monitor* points out Thomas wasn't exactly first in line to rip into VisitDallas leadership when we all found out ~~how the shop was run~~ a few months back.

But the scoop is this: the *Monitor* got **D** hands on Thomas' **last three years** of annual gift disclosures. The tickets aren't on them.

Tickets for each of those events exceeded the \$50 minimum required for disclosure. Mars, for example, **charged \$591 for a top seat** during his 2018 tour.

Although the annual gift disclosure filed by Thomas did not mention the American Airlines Center events, it did include other perks he received from VisitDallas. He reported receiving two tickets to the AT&T Byron Nelson golf tournament from VisitDallas in May 2018, worth \$300 each, and an \$85 polo shirt in 2017.

Thomas did not respond to a phone message or text requesting comment. His office did not respond to an email.

He hasn't responded here, either. We'll update if he does. Former Councilwoman Monica Alonzo, she of West Dallas, used the suite twice during her time in office.
